THIS IS A SUMMARY OF THE ANNUAL REPORT FOR THE NORTH CAROLINA BAR ASSOCIATION HEALTH BENEFIT TRUST, (EMPLOYER IDENTIFICATION NO. 56-0583941, PLAN NO. 501) FOR THE PERIOD OCTOBER 1, 2021 TO SEPTEMBER 30, 2022. THE ANNUAL REPORT HAS BEEN FILED WITH THE EMPLOYEE BENEFITS SECURITY ADMINISTRATION, AS REQUIRED UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA).

THE VALUE OF PLAN ASSETS, AFTER SUBTRACTING LIABILITIES OF THE PLAN, WAS \$21,190,127 AS OF SEPTEMBER 30, 2022 COMPARE TO \$26,809,379 AS OF OCTOBER 1, 2021. DURING THE PLAN YEAR THE PLAN EXPERIENCED A DECREASE IN ITS NET ASSETS OF \$5,619,252. THIS DECREASE INCLUDES UNREALIZED APPRECIATION OR DEPRECIATION IN THE VALUE OF THE PLAN ASSETS; THAT IS, THE DIFFERENCE BETWEEN THE VALUE OF THE PLAN'S ASSETS AT THE END OF THE YEAR AND THE VALUE OF THE ASSETS AT THE BEGINNING OF THE YEAR, OR THE COST OF ASSETS ACQUIRED DURING THE YEAR.DURING THE PLAN YEAR, THE PLAN HAD TOTAL INCOME OF \$47,796,763. THIS INCOME INCLUDED EMPLOYER CONTRIBUTIONS OF \$50,353,673, REALIZED GAINS OF \$14,751 FROM THE SALE OF ASSETS AND EARNINGS FROM INVESTMENTS OF \$-2,571,661. PLAN EXPENSES WERE \$53,416,015. THESE EXPENSES INCLUDED \$6,338,798 IN ADMINISTRATIVE EXPENSES AND \$47,077,217 IN BENEFITS PAID TO PARTICIPANTS AND BENEFICIARIES.
